This is a quiet rural area, yet only minutes from shopping, dining, and a hospital. The property has over 1,700 feet of frontage on the Lumber River. There is an access point at Lumber River State Park just down the road for canoeing, fishing, and duck hunting. The Lumber River is a nationally recognized Wild and Scenic River. Additional acreage is available. Buyer will be responsible for the survey.
